ABSTRACT

This study focuses on the mechanism to implement effectively renovation process of monetary policy in Vietnam, define the necessary conditions and concrete solutions for carrying out effective monetary policy and to complete the monetary policy in the structure of Vietnam's policies.

Chapter 1 reviews the role of monetary policy in economic development and the rationale of the need of the monetary policy renovation in Vietnam and states the objective of the study.

Chapter 2 overview of monetary circulation mechanism, the monetary management before renovation period and the necessary of reform of these policies in accordance with the new economic structure.
