Abstract

In view of limited published studies about the board room practices in local corporations, this exploratory research is proposed to obtain some qualitative data of the local corporate governance structure.

A total of ten board members from the local public listed companies were interviewed on their experience as board members. They were also being approached on personal opinions with relevant to some corporate governance issues.

Western literatures and Companies Act 1965 were used as main references to lay the basic roles, responsibilities and controls of corporate board.

The research findings showed there are still lacking of corporate governance in our corporations. Some further studies on the some topics are proposed.
