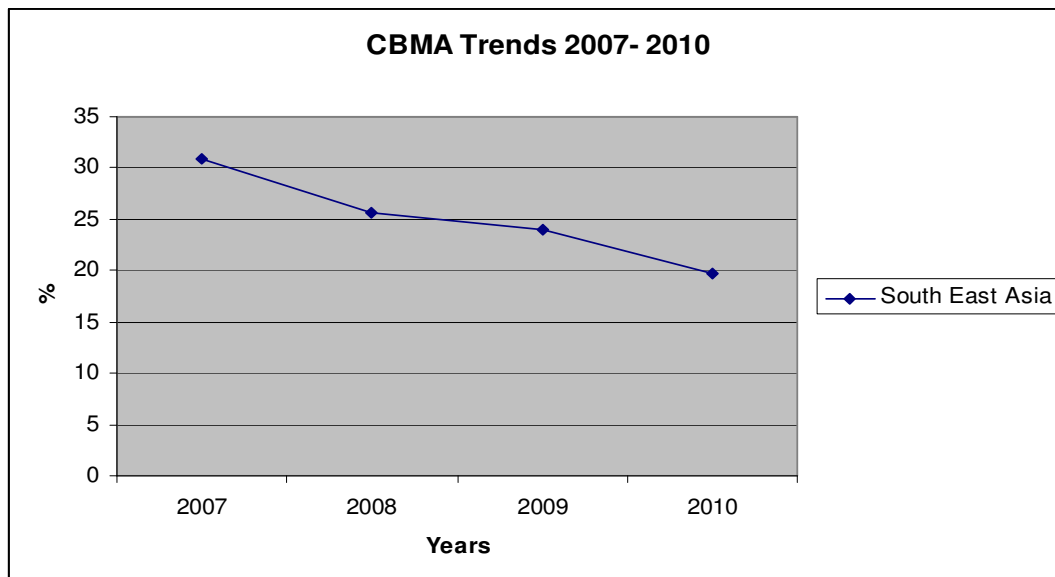

Figure Percentages CBMA Trend in Indonesia, Malaysia, Philippines and Thailand from 2007-2010.



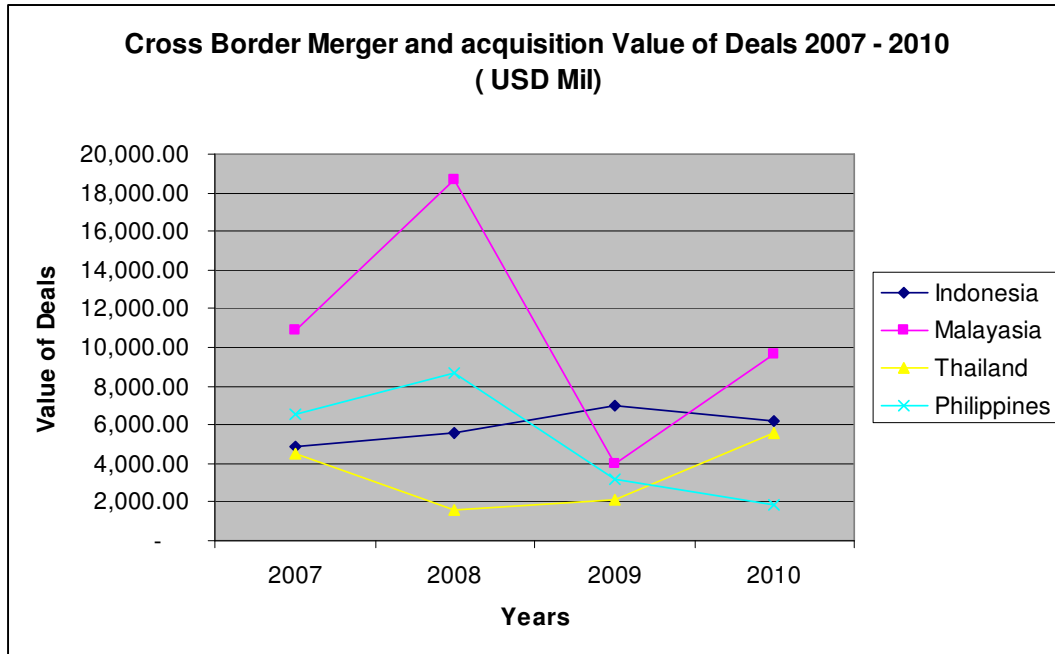
