- 6) **RHB** - Merger of Kwong Yik and D&C Bank in 1996
Later bought over Sime Bank
- 7) **Hong Leong** - Initially Kwong Lee Bank, 1982 changed to MUI Bank and
in 1994 became Hong Leong Bank
- 8) **Chung Khaw** - Merged with UOB in 1997
- 9) **UAB** - Merged with BOC in 1991.
- 10) **BBMB** - Merged with BOC in 1999 to become Bumiputera Commerce
Bank
